Written Questions should be submitted no later than two working days prior to the meeting in order that they can be included on the agenda.

Attending Meetings - Members of the Public can attend our meetings, subject to venue capacity limitations – please contact the office to discuss numbers and to let us know you wish to attend. We welcome spoken representations and questions for the committee, but these must relate to the business listed on the agenda for that meeting.

In accordance with Newquay Town Council's Standing Orders, the following protocols will be applied:

- A member of the public shall not speak for more than three minutes.
- The period of time designated for public participation at a meeting shall not exceed fifteen minutes unless directed by the chairman of the meeting.
- A question, written or otherwise, shall not require a response at the meeting nor start a debate on the question. The Chair of the meeting may direct that a written or oral response be given.

Whilst we are very pleased to be holding face-to-face meetings in the Council Chambers once again, there are a few bits of 'housekeeping' you will need to familiarise yourselves with before the meeting:

YOU ARE REQUIRED TO SIGN IN USING OUR VISITORS BOOK
