

Dear Mayor and Newquay councillors,

I am writing with great concern about the Pfizer vaccines being given in schools this week, mainly because they have no long term data, can be given without parental consent, the vaccines are approved under emergency measures and still in trial until full approval until May 2023 (if they get it). The JCVI did not approve these vaccines for healthy children. The public are the long term data.

I have many concerned parents and as councillors it is our job to serve them, question government policies and bring the government into line. These votes should go back to Cornwall council and preferably they should also vote on them and send them to parliament.

I would like to table this on the agenda this week for all councillors to vote as to whether we agree these vaccines should as follows

1. Should the government be giving covid-19 vaccines to children against the advice of the JCVI.
2. Whether the covid-19 vaccines should be given in schools instead of doctors/clinics considering they are under emergency approval with no long term data.
3. Whether vaccines should be given to children without parental consent which is actually against legislation when still not fully approved and considered still on trial.
4. A vote on the implementation of vaccine passports for the public.
5. A vote on whether the covid-19 vaccine should be mandatory in care homes or medical considering carers have already lost their jobs locally which has now put huge pressures on our care system. The elderly are bed blocking our hospitals because there is not enough staff in the care homes to care for them. The state of our medical services at the moment needs urgent review at local and county level.

If this cannot be voted on I would like to know why and if it is a time issue can I please have each of our councillors agree or disagree to the five questions in my email, the public have a right to know who values their freedoms and get to know who is representing them on these issues. Any abstentions would be viewed as hiding behind the issue and not in the best interests of the voting residents.
