Community Safety Reports

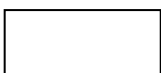
No representative present, a written report was supplied by Acting Inspector Johnson, questions will be asked via email.

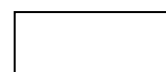

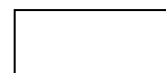
