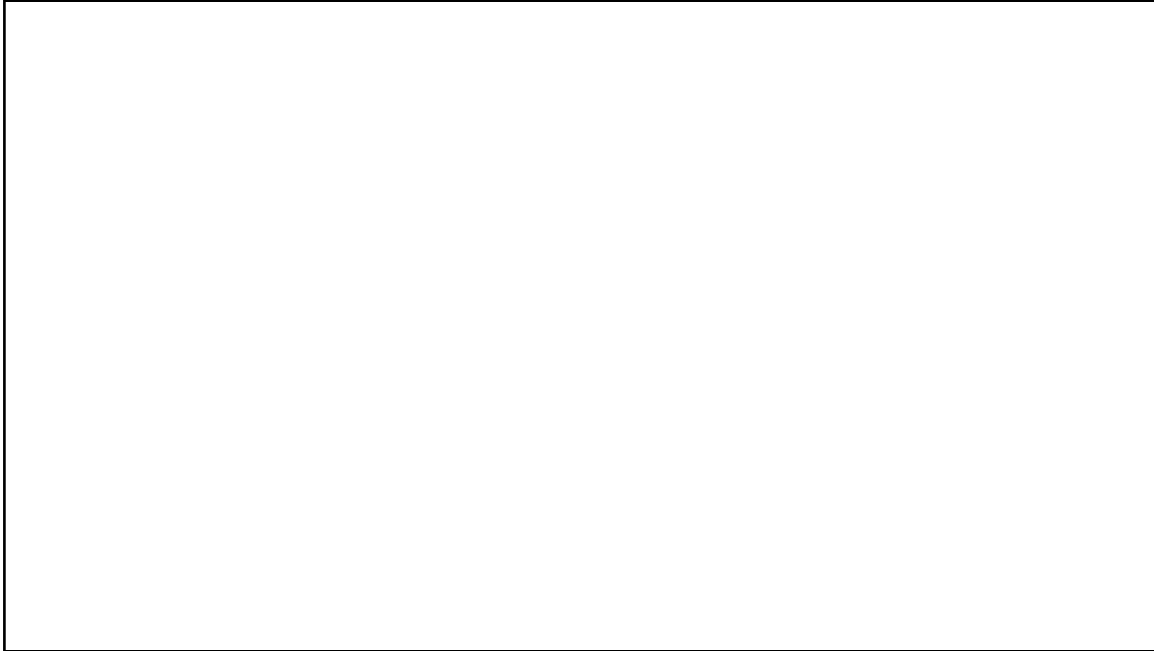

The trailer will not be parked within 2 metres of the access points as identified by the plan that accompanied the application

The trailer currently has adequate litter bins for the compostable coffee cups and pastry bags and this will be tripled to cope with the demand of the season. The bins are provided for the use of customers only and will be monitored regularly by staff. The bins are located next to the trailer and will be emptied regularly. Full bin bags are put into the used bin bag container in the rear of the Land Rover.

The Truck and Trailer will arrive early in the morning to secure a trading spot in the specified location. At the end of each trading day the trailer will be taken to a secure lock up in Newquay where a full clean down is done, ready for the next trading day.

Only Card Payments will be accepted, perspex screens are in place at the serving hatch, and customers are required to wear facemasks when ordering. Waiting markers will be placed along the trailer.

The trailer runs off of gas and solar power and therefore a generator is not required.
